Our measurements show oral sodium ascorbate only raises blood vitamin C levels 8 times steady state in 25 minutes)

The new **UltraFINE™** is the finest powder (ultra-fine) of the highest-quality product on the market which has been branded and trademarked as [Quali-C\\*\\*\\*®](#) manufactured by DSM Nutritional products.

Vitamin C expert Robert Cathcart III, MD, had the most clinical experience administering high-dose vitamin C to his patients. Dr. Cathcart considered the ascorbic acid form of vitamin C to be twice as potent orally as the sodium ascorbate forms for many therapeutic applications.
